### **Concerning: Article 7.3 authorisation - RUS Bureau - Georgia and Kazakhstan - 2018**

Dear colleagues,

This is to inform you that the Management Committee approved, on 26th September, your Bureau's request for authorisation to issue Green Cards for vehicles registered in Georgia. The authorisation will enter into force on 01/01/2018 and will be valid for one calendar year thereafter (i.e. until 31/12/2018 inclusive).

At the same time, in accordance with the approval procedure under the Explanatory Memorandum under Article 7.3 of the Internal Regulations, your Bureau's authorisation to issue Green Cards for vehicles registered in Kazakhstan was renewed for the following year, i.e. 01/01/2018-31/12/2018 inclusive.

Please note that this authorisation is granted under the conditions that (and remains valid as long as):

- (a) the Bureau of Russia is not under "Monitoring" status; and
- (b) the reinsurance covers of the Bureau of Russia and/or any of its members authorised to issue Green Cards for vehicles registered in Georgia and Kazakhstan extend to this activity (including for false or unauthorised Green Cards, whether guaranteed by the Bureau or by its member(s)).

If, at any time in the course of the period of validity of this approval, these conditions are not or no longer fulfilled, this approval shall automatically terminate as of the date of such non-fulfilment.

By force of obtaining this authorisation your Bureau renounces the right to invoke Article 9.2 of the Internal Regulations (non-application of a Bureau's guarantee for a Green Card relating to a vehicle not legally registered in your Bureau's country) for any Green Cards issued, or purported to be issued, under the authority of your Bureau.

Please also note that, according to the same approval procedure, you are expected to provide annual statistical data about the number of Green Cards issued and claims incurred during the previous year. This will most likely be organised in the framework of the CoB annual enquiry on Green Cards issued by Member Bureaux in countries where no Bureau exists (usually sent out in the first trimester of every year); from 2018 onwards, we plan to provide you with an updated template that will include claim statistics.


